## Directions to Beloit Memorial Hospital:

**Approaching Beloit from the north or south on I-90:** Take the WI Hwy. 81 exit. Turn right onto Cranston Rd (just past Wal-Mart).

Continue on Cranston Rd to Prairie Ave. Turn right. Continue on Prairie Ave. to Hart Rd. (just past Shopko & Pizza Hut). Turn right.

**Approaching Beloit from the east on I-43:**

I-43 becomes Hwy 81 at the intersection with I-90. Follow directions above for I-90.

**Approaching Beloit from the south on Hwy.**

**251:** Follow Hwy. 251 to where U.S. Hwy. 51 begins. Follow Hwy. 51 north through Beloit past the YMCA to the traffic light at Cranston Rd. Turn right. Continue on Cranston Rd to the second traffic light at Prairie Ave. Turn left. Continue on Prairie Ave. to Hart Rd. (just past Shopko & Pizza Hut). Turn right.

**Approaching Beloit from the south on**

**Hwy. 2:** Follow Hwy. 2 through South Beloit. Follow signs for U.S. Hwy. 51 North. Follow directions for Hwy 51 above.

**Approaching Beloit from the west on**

**Hwy 81:** Traveling east on Hwy. 81 (Liberty Ave.) to the third set of traffic lights (4<sup>th</sup> St.). Turn left. Continue across the river. At the first traffic lights, Riverside Dr (Hwy. 51) turn left. Follow directions for Hwy 51 above.

**Approaching Beloit from the north on US**

**Hwy 51:** Follow US Hwy 51 to traffic lights at Cranston Rd. Turn left. Continue on Cranston Rd to 2<sup>nd</sup> traffic light at Prairie Ave. Turn left. Continue on Prairie to Hart Rd (just past Shopko & Pizza Hut). Turn right.

**Approaching Beloit from the northwest on**

**Hwy 213:** Traveling south on WI Hwy 213, turn left at County Q (Newark Rd). Continue on County Q to US Hwy 51. Turn right. Follow directions for Hwy 51 above.

**Approaching Beloit from the north on**

**County G:** County G is Prairie Avenue follow south to Hart Rd. Turn left.
